Welcome to ListedNew, a network of websites, mobile applications, and online services geared towards the promotion of newly constructed homes in Canada. ListedNew (collectively referred to herein as the "Service") is owned and operated by Spacetime Innovations Inc. and is comprised of the following websites:

ListedNew is committed to protecting the privacy and security of your personal information. This Privacy Policy outlines how we collect, use, disclose, and protect the information you provide when you use our Service.

A. Information We Collect

We collect and process various types of information to provide and improve our Service. The types of information we may collect include:

1. Personal Information

This may include, among other items, your name, profile picture, email address, phone number, address, and any other information you provide when registering or making a transaction on our Service.

2. Usage Information

We collect information about how you interact with our Service, including your IP address, Internet service provider, browser type, browser version, device type, operating system, location, language preference, referring URL, searched keywords, pages visited, time spent on each page, unique device identifiers, and other diagnostic data.



3. Cookies and Similar Technologies

We may use cookies, web beacons, and similar technologies to collect information about your browsing activities and preferences. You can control the use of cookies through your browser settings.

B. Use of Information

We may use the information we collect for the following purposes:

- 1. To provide and maintain our Service.
- 2. To process and manage advertisements posted on our website.
- 3. To communicate with you, respond to your inquiries, and provide customer support.
- 4. To personalize your experience and improve our Service.
- 5. To detect, prevent, and address technical issues and security vulnerabilities.
- 6. To comply with legal and regulatory requirements.

C. Disclosure of Information

We may disclose your information to third parties for the following purposes:

- 1. To service providers and business partners who assist us in operating our website and providing our Service.
- 2. If we are involved in a merger, acquisition, or asset sale, your personal information may be transferred.
- 3. To comply with legal obligations, such as responding to lawful requests from government authorities.
- 4. To protect our rights, property, or safety, and the rights, property, or safety of others.
- 5. To prevent or investigate possible wrongdoing in connection with our Service.
- 6. To protect against legal liability.



D. Data Security

We protect your personal data with technical and administrative security measures such as firewalls, data encryption, and physical and administrative restrictions on access to data. The security of your personal data is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your personal data, we cannot guarantee its absolute security.

The personal data collected is stored on servers that may be physically located in another province or country thereby becoming available to other government authorities and subject to the laws of that jurisdiction. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy.

E. Retention of Personal Information

We will retain your personal information only as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your personal information to the extent necessary to comply with our legal obligations (for example, if we are required to retain your information to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies. We will also retain usage information for internal analysis purposes. Usage information is generally retained for a shorter period of time, except when this information is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this information for longer time periods.
